- 4. Campers are expected to take good care of the camp facility, equipment and supplies. These items are to be used only for their intended purpose. If a camper damages any item, parents will be responsible for replacement.

DISCIPLINE

1st Offense: Verbal Correction

 2^{nd} Offense: As a dance camp if we have discipline problems we do sometimes choose to give physical correction via reasonable stretching or exercise that positively helps the camper grow as a dancer.

3rd Offense: Parent Phone Call

4th Offense Dismissal From a Field Trip

5th Offense Camp Suspension

6th Offense Camp Expulsion

NOTE: Depending on the severity of offense, camper may not go through all 6 forms of discipline but skip steps of discipline to receive more severe consequences.
